



2019 Girl Scouts Heart of the Hudson, Inc. Juliette Gordon Low Leadership Award Nomination Form

Description and Criteria

When Juliette Gordon Low founded Girl Scouts over 106 years ago, she recognized the value of developing girls' leadership abilities right from the start. She started a movement that has endured and achieved her vision of developing girls into leaders. In honor of Girl Scout leadership ideals, Girl Scouts Heart of the Hudson will honor a young adult Girl Scout alumna who has demonstrated exceptional leadership in her professional or volunteer life.

The Annual Girl Scouts Heart of the Hudson (GSHH) Juliette Gordon Low Leadership Award will be presented at the *GSHH Spring Luncheon - Honoring Women of Distinction*, scheduled for **Thursday, April 25, 2019**, at **Brae Burn Country Club, Purchase, NY**.

The nominee should be a young woman between the ages of 21 and 35, who participated in Girl Scouting as a girl for at least three years, and has distinguished herself as an exceptional leader in her chosen profession and/or current volunteer capacity in her community. The nominee needs to have held a leadership position for a minimum of one year either in a professional, community, or volunteer role.

The GSHH Juliette Gordon Low Leadership Award nominee should embody the tenets of the Girl Scout promise and law.

Girl Scout Mission: "Girl Scouting builds girls of courage, confidence, and character, who make the world a better place."

Girl Scout Promise: "On my honor, I will try: to serve God and my country, to help people at all times and to live by the Girl Scout Law."

Girl Scout Law: "I will do my best to be honest and fair, friendly and helpful, considerate and caring, courageous and strong, and responsible for what I say and do, and to respect myself and others, respect authority, use resources wisely, make the world a better place, and be a sister to every Girl Scout."

Nomination Process

Nominations can be made by the nominee business colleagues, family, friends, fellow Girl Scout alumna, or any community organization. All nominations must include the following:

1. A completed nomination form with accompanying questionnaire
2. A letter of recommendation from a non-family member
3. Nominee bio and/or resume
4. Evidence of the nominee's Girl Scout participation, (i.e., troop number if applicable), and provide the name of the GS volunteer or GSHH staff member who can verify the nominee's participation. Please do not send any other information.
5. Two additional pages of documentation (if needed)

Submission Process: All nominations must be received by February 28, 2019, at 5pm.

Announcements will be made in March 2019.

Please submit the entry as a PDF or word document.

5. What are the nominee's top three most important leadership qualities? Please describe.


6. Does the nominee currently volunteer in her community? If so, in what capacity?
