POSITION SUMMARY:

To guide campers in the leadership programs throughout experience in accordance with standards set by GSUSA, ACA, and the New York State Health Department and to direct and supervise the work of the counselors working with the leadership programs.

KEY FUNCTIONS & RESPONSIBILITIES:

- Instructs CITs according to the CIT curriculum which will facilitate development of skills in camping activities, outdoor living and leadership necessary to work effectively with children and will increase their understanding of children, camping and Girl Scout program, philosophy and objectives.
- Instructs leadership campers according to their program’s curriculum which facilitate the development of key basic leadership skills and increase their understanding of faciliation best practices and and Girl Scout program, philosophy and objectives.
- Implements age-appropriate leadership activities to ensure the gradual progress throughout the leadership program over time.
- Supervises, supports, and evaluates leadership campers in partnership with assigned unit and program staff.
- Coordinates leadership unit(s) activities with those of the entire camp.
- Assumes responsibility for health and safety of the leadership program campers:
- maintains a well-equipped first aid kit;
- reports accidents promptly;
- Keep nurse informed of health status of campers and unit staff.
- Keeps records and makes reports as directed by Camp Director/Assistant Camp Director.

QUALIFICATIONS:

- Successful completion of background check.
- Must be at least 18 years old
- Must have high school diploma or equivalent.
- Experienced as a camp counselor and/or working with older girls.
- Demonstrated leadership abilities.
- Girl Scout experience preferred.
- Ability to stand for long periods.

- Capable of lifting and carrying items over 15 lbs.
- Proficient in navigating rough terrain.
- Comfortable being active for extended durations
